ATT biex ikompli jemenda l-Att ta' l-1948 dwar il-Pensjonijiet għax-Xjuħ.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'liġi dan li ġej:—

1. (1) Dan l-Att jista' jissejjah l-Att ta' l-1979 li jemenda l-Att dwar il-Pensjonijiet għax-Xjuħ, u għandu jinqara u jftiehem haġa waħda ma' l-Att ta' l-1948 dwar il-Pensjonijiet għax-Xjuħ, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

(2) L-artikolu 4 ta' dan l-Att għandu jkollu effett mill-20 ta' Jannar, 1979.

2. L-artikolu 5 ta' l-Att prinċipali għandu jiġi emendat kif ġej:

(a) minflok il-paragrafu (b) tas-subartikolu (1) tiegħu għandu jidhol dan li ġej:

“(b) il-persuna turi għas-sodisfazzjon tal-Ministru li tkun ċittadin ta' Malta u li tkun irrisjediet f'Malta għal perijodu totali ta' mhux inqas minn tnax-il sena minn meta tkun għalqet l-età ta' hamsa u erbghin sena; u ”;

(b) minflok il-paragrafu (c) tas-subartikolu (2) tiegħu għandu jidhol dan li ġej:

“(c) il-persuna turi għas-sodisfazzjon tal-Ministru li tkun ċittadin ta' Malta u li tkun irrisjediet f'Malta għal perijodu totali ta' mhux inqas minn għaxar snin minn meta tkun għalqet l-età ta' erba' snin; u”, u

(c) minflok il-paragrafu (c) tas-subartikolu (2A) tiegħu għandu jidhol dan li ġej:

“(ċ) il-persuna turi għas-sodisfazzjon tal-Ministru li tkun ċittadin ta' Malta u li tkun irrisjediet f'Malta għal perijodu totali ta' mhux inqas minn għaxar snin minn meta tkun għalqet l-età ta' sitt snin, u”.

3. Minnufih wara l-artikolu 16 ta' l-Att prinċipali għandu jiż-
died l-artikolu ġdid li ġej:

16A. Il-Ministru jista', b'ordni, jestendi l-applikazzjoni ta' dan l-Att għal persuni li ma jkunux ċittadini ta' Malta sabiex jinghata effett lil xi konvenzjoni, ftehim jew arrangament li fih Malta tkun parti u li jipprovdi għal reċiproċità fl-għoti ta' pensjonijiet jew *allowances* mhux kontributorji.”.

4. Minflok il-paragrafi 1 u 2 ta' l-Iskeda li tinsab ma' l-Att prinċipali għandu jidhol dan li ġej:

Għanijiet u Raġunijiet

L-Għan ta' dan l-Abbozz huwa li jzid il-pensjoni li tithallas taht l-Att ta' l-1948 dwar il-Pensjonijiet għax-Xjuħ, u li jillimita l-applikazzjoni tiegħu għal ċittadini ta' Malta, b'dan li jista' jiġi estiż b'ordni, għal ċittadini ta' pajjiżi oħra li magħhom ikun hemm fis-seħh konvenzjoni, ftehim jew arrangament relattiv.

A BILL

entitled

AN ACT further to amend the Old Age Pensions Act, 1948.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement.

1. (1) This Act may be cited as the Old Age Pensions (Amendment) Act, 1979, and shall be read and construed as one with the Old Age Pensions Act, 1948, hereinafter referred to as "the principal Act".

(2) Section 4 of this Act shall have effect as from the 20th day of January, 1979.

Amendment of section 5 of the principal Act.

2. Section 5 of the principal Act shall be amended as follows:

(a) for paragraph (b) of subsection (1) thereof there shall be substituted the following:

"(b) the person shall show to the satisfaction of the Minister that he is a citizen of Malta and that he has resided in Malta for an aggregate period of not less than twelve years since attaining the age of forty-five years; and";

(b) for paragraph (c) of subsection (2) thereof there shall be substituted the following:

"(c) the person shall show to the satisfaction of the Minister that he is a citizen of Malta and that he has resided in Malta for an aggregate of not less than ten years since attaining the age of four years; and", and

(c) for paragraph (c) of subsection (2A) thereof there shall be substituted the following:

"(c) the person shows to the satisfaction of the Minister that he is a citizen of Malta and that he has resided in Malta for an aggregate period of not less than ten years since attaining the age of six years, and".

3. Immediately after section 16 of the principal Act there shall be added the following new section:

Addition of new section 16A to the principal Act.

"Extension of application of Act.

16A. The Minister may, by order, extend the application of this Act to persons who are not citizens of Malta in order to give effect to any convention, agreement or arrangement to which Malta is a party and which provides for reciprocity in the grant of non-contributory pensions or allowances."

4. For paragraphs 1 and 2 of the Schedule to the principal Act there shall be substituted the following:

Amendment of Schedule to the principal Act.

"(1) Where the total yearly means of a married couple (not being separated in accordance with the provisions of the Civil Code, and both persons being entitled to a pension under this Act) calculated in accordance with the provisions of this Act —

	Weekly rate of pension per person
do not exceed £100	£7.55,0
exceed £100 but do not exceed £200	£6.30,0
exceed £200 but do not exceed £300	£5.05,0
exceed £300 but do not exceed £400	£3.80,0
exceed £400	No pension.

(2) Where the yearly means of any other claimant or pensioner calculated in accordance with the provisions of this Act —

	Weekly rate of pension per person
do not exceed £50	£9.60,0
exceed £50 but do not exceed £100	£8.15,0
exceed £100 but do not exceed £150	£6.70,0
exceed £150 but do not exceed £200	£5.15,0
exceed £200	No pension".

Objects and Reasons

The Object of this Bill is to increase the pension payable under the Old Age Pensions Act, 1948, and to limit its application to citizens of Malta, subject to it being extended, by order, to nationals of other countries with which there may be in force a relative convention, agreement or arrangement.
