L-għan ewlieni ta' dan l-Abbozz huwa li b'effett minn din is-sena, is-sena finanzjarja tal-Gvern tibda ttemm fil-31 ta' Diċembru minflok fil-31 ta' Marzu. Is-sena finanzjarja ta' ċerti korpijiet mwaqqfin b'liġi kif ukoll xi snin finanzjarji stabbiliti għal għanijiet fiskali u għal għanijiet oħra qed jinbidlu wkoll minhabba t-tibdil ewlieni kif ukoll minhabba li xi whud minn dawn il-korpijiet għandhom jissottomettu lill-Parlament l-estimi tagħhom separatament.

A BILL
entitled

AN ACT to prescribe the period of the financial year.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Financial Year Act, 1979. Short title.

2. For the purposes of the Constitution, and as provided by section 126 thereof, it is hereby prescribed that the 31st day of December shall be the date on which every financial year, subsequent to that ending on the 31st March, 1979, shall end. End of financial year.

3. The enactments specified in the first column of the Schedule hereto shall have effect subject to the amendments specified in the second column of that Schedule. Amendments of Enactments in Schedule.

No. XXV of 1961)	In subsection (2) of section 8, for the words "shall be calculated to the thirty-first day of March in every year" there shall be substituted the words "shall be calculated, until the year 1979, to 31st March and again from 1st April to 31st December of that year, and, for any subsequent year, to 31st December in every year"; In section 11, for the words "ending on each thirty-first day of March" there shall be substituted the words "ending, until the year 1979, on 31st March and again during the nine months ending on 31st December of that year, and subsequently during the year ending on 31st December of each year"; In subsection (3) of section 12, for the words "If on the thirty-first day of March" there shall be substituted the words "If on 31st March in any year until the year 1979, and again on 31st December of the said year, and if on 31st December in any subsequent year".

Objects and Reasons

The main purpose of this Bill is to change with effect from this year, the Government's financial year from one ending on 31st March to one ending on 31st December. The financial years of certain statutory bodies as well as certain financial years established for fiscal and other purposes are also being changed to take account of the main change as well as the requirement of some of those bodies to submit to Parliament their own separate estimates.
