AN ACT further to amend the Shops and Hawkers (Business Hours) Act, 1957.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Shops and Hawkers (Business Hours) (Amendment) Act, 1979, and shall be read and construed as one with the Shops and Hawkers (Business Hours) Act, 1957, hereinafter referred to as "the principal Act".

Amendment of section 6 of the principal Act.

2. The two provisos to subsection (1) of section 6 of the principal Act and subsection (2) of the said section 6 shall be deleted.

Amendment of section 12 of the principal Act.

3. In subsection (1) of section 12 of the principal Act, for the words "of the First Schedule" there shall be substituted the words "of the Schedule".

Amendment of First Schedule to the principal Act.

4. For the heading "First Schedule" immediately after section 13 of the principal Act there shall be substituted the heading "Schedule".

5. The Second Schedule to the principal Act is hereby repealed.
