1. (1) Dan l-Att jista' jissejjaħ l-Att ta' l-1977 li jemenda l-Att dwar is-Sigurtà Nazzjonali, u għandu jinqara u jiftiehem ħaġa waħda ma' l-Att ta' l-1956 dwar is-Sigurtà Nazzjonali, hawnhekk iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

(2) Dan l-Att għandu jibda jseħħ fis-7 ta' Marzu, 1977.

Emenda ta'

2. L-artikolu 2 ta' l-Att prinċipali għandu jiġi emendat kif ġej:

(a) minnufih wara t-tifsira ta' "impieg eċċettwat" għandha tidhol it-tifsira ġdida li ġejja:

"età assigurabbli" tfisser l-età ta' dsatax-il sena jew, wara t-3 ta' April, 1977, l-età ta' tmintax-il sena;"

(b) minflok il-kliem "ta' aktar minn dsatax-il sena u taħt l-età tal-pensjoni" fit-tifsira ta' "persuna mhux impjegata" għandhom jidhlu l-kliem "ta' età assigurabbli u taħt l-età tal-pensjoni";

(c) fit-tifsira ta' "persuna li timpjega lilha nnifisha" minflok il-kliem "fuq l-età ta' dsatax-il sena" kull fejn jinsabu fil-paragrafi (a) u (b) tagħha għandhom jidhlu l-kliem "fuq l-età assigurabbli", u

(d) minflok il-kliem "id-dsatax-il sena" u "tad-dsatax l-anniversarju" fil-paragrafu (c) tas-subartikolu (3) tiegħu għandhom jidhlu l-kliem "it-tmintax-il sena" u "it-tmintax l-anniversarju" rispettivament.

3. L-artikolu 12 ta' l-Att prinċipali għandu jiġi emendat kif ġej: Emenda ta' l-artikolu 12 ta' l-Att prinċipali.

(a) fis-subartikolu (i) tiegħu, minflok il-kliem "bejn id-satax-il sena u l-età ta' pensjoni" għandhom jidhru l-kliem "bejn l-età assigurabbli u l-età ta' pensjoni";

(b) minnufih wara s-subartikolu (1) tiegħu għandu jizdied il-proviso li ġej:

"Izda l-persuna assigurata ma jkollhiex dritt għal benefiċċju għal mard għall-ewwel tlett ijiem ta' kull darba ta' inkapaċità għax-xogħol.", u

(ċ) minflok is-sub-paragrafu (ii) tal-paragrafu (a) tas-sub-artikolu (4) tiegħu għandu jidhrol dan li ġej:

5. Minflok il-paragrafu (e) ta' l-artikolu 14 ta' l-Att prinċipali għandu jidhrol dan li ġej: Emenda ta' l-artikolu 14 ta' l-Att prinċipali.

"(e) tkun għamlet xogħol li għalih kien jithallas, jew kien ordinarjament jithallas, kumpens, hlief jekk kien xogħol magħmul taħt sorveljanza medika bħala parti mill-kura tagħha waqt li kienet pazjenta fi sptar jew ta' sptar jew istitut ieħor bħal dan, u l-qliegħ tagħha dwar dak ix-xogħol ma kienx iżjed minn £1.00,0 fil-ġimgħa fil-każ ta' persuna ta' età assigurabbli jew 40c fil-ġimgħa fil-każ ta' persuna taħt l-età assigurabbli;"

6. Minnufih wara l-paragrafu (a) tas-subartikolu (1) ta' l-artikolu 19 ta' l-Att prinċipali għandu jizdied il-proviso li ġej: Emenda ta' l-artikolu 19 ta' l-Att prinċipali.

"Izda persuna li tkun skwalifikata li tircievi benefiċċju għal korriment skond l-artikolu 26 ta' dan l-Att ikollha d-dritt għall-benefiċċju tagħha mnaqqas bin-numru ta' ġranet ta' skwalifika."

7. Minnufih wara l-artikolu 23 ta' l-Att prinċipali għandu jizdied il-proviso li ġej: Emenda ta' l-artikolu 23 ta' l-Att prinċipali.

"Izda ma jkollhiex hekk dritt għall-benefiċċju għal korriment għall-ewwel tlett ijiem ta' kull darba ta' inkapaċità għax-xogħol."

Emenda ta' l-artikolu 34 ta' l-Att prinċipali.

8. Minnufih wara s-subartikolu (2) ta' l-artikolu 34 ta' l-Att prinċipali għandu jiżded is-subartikolu ġdid li ġej:

“(3) Meta talba għal benefiċċju skond dan l-Att għandu jkollha magħha ċertifikat mediku, ebda ċertifikat bħal dak ma jkun aċċettat bħala validu jekk ikun iffirmit minn tabib li jkun ukoll membru tal-Kamra tad-Deputati jew minn soċju tiegħu jew minn assoċjat miegħu, jew minn xi tabib ieħor li jkollu relazzjoni simili miegħu.”.

Sostituzzjoni ta' l-artikolu 72 ta' l-Att prinċipali.

9. Minflok l-artikolu 72 ta' l-Att prinċipali għandu jidhol dan li ġej:

“72. Ir-rata ta' l-allowance tkun —

(a) dwar lewwel tifel eliġibbli — mija u għaxar ċenteżmi fil-ġimgħa; u

(b) dwar it-tieni tifel eliġibbli — disgħin ċenteżmu fil-ġimgħa; u

(ċ) dwar it-tielet tifel eliġibbli — ħamsin ċenteżmu fil-ġimgħa.”.

Emenda ta' l-artikolu 80 ta' l-Att prinċipali.

10. Fl-artikolu 80 ta' l-Att prinċipali, minnufih qabel il-kliem “ta' l-artikoli mill-41” għandhom jidhlu l-kliem “ta' l-artikolu 38”.

ACT No. IV of 1977

AN ACT further to amend the National Insurance Act, 1956.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement

1. (1) This Act may be cited as the National Insurance (Amendment) Act, 1977, and shall be read and construed as one with the National Insurance Act, 1956, hereinafter referred to as "the principal Act".

(2) This Act shall come into force on the 7th day of March, 1977.

Amendment of section 2 of the principal Act

2. Section 2 of the principal Act shall be amended as follows:

(a) immediately after the definition of "excepted employment" there shall be inserted the following definition:

"insurable age" means the age of nineteen years or, after the 3rd day of April, 1977, the age of eighteen years;"

(b) for the words "over the age of nineteen years and under pension age" in the definition of "non-employed person" there shall be substituted the words "of insurable age and under pension age";

(c) in the definition of "self-employed person", for the words "over the age of nineteen years" wherever they occur in paragraphs (a) and (b) thereof there shall be substituted in each case the words "over insurable age", and

(d) for the words "nineteen years" and "nineteenth anniversary" in paragraph (c) of subsection (3) thereof there shall be substituted the words "eighteen years" and "eighteenth anniversary" respectively.

3. Section 12 of the principal Act shall be amended as follows: Amendment of section 12 of the principal Act.
- (a) in subsection (1) thereof, for the words "is between the age of nineteen and pension age" there shall be substituted the words "is between insurable age and pension age";
- (b) immediately after subsection (1) thereof there shall be added the following proviso:
- "Provided that the insured person shall not be entitled to sickness benefit for the first three days of each spell of incapacity for work.", and
- (c) for sub-paragraph (ii) of paragraph (a) of subsection (4) thereof there shall be substituted the following:
- "(ii) the earnings derived therefrom in respect of that day do not exceed £1.00,0 in respect of a person of insurable age and 40c in the case of a person under insurable age, or where the earnings are earned in respect of a period longer than a day, the earnings do not on a daily average exceed those amounts respectively."
4. Immediately after subsection (2) of section 13 of the principal Act there shall be added the following proviso: Amendment of section 13 of the principal Act.
- "Provided that a person who is disqualified for receiving benefit in accordance with sections 14 and 15 of this Act shall have his entitlement to benefit reduced by the number of days of disqualification."
5. For paragraph (e) of section 14 of the principal Act there shall be substituted the following: Amendment of section 14 of the principal Act.
- "(e) he has done work for which remuneration was or would have ordinarily been payable unless it was work which was undertaken under medical supervision as part of his treatment while he was a patient in or of a hospital or other similar institution, and his earnings in respect of that work did not exceed £1.00,0 a week in the case of a person of insurable age or 40c a week in the case of a person under insurable age."
6. Immediately after paragraph (a) of subsection (1) of section 19 of the principal Act there shall be added the following proviso: Amendment of section 19 of the principal Act.
- "Provided that a person who is disqualified from receiving injury benefit in accordance with section 26 of this Act shall have his entitlement to benefit reduced by the number of days of disqualification."
7. Immediately after section 23 of the principal Act there shall be added the following proviso: Amendment of section 23 of the principal Act.
- "Provided that he shall not be so entitled to injury benefit for the first three days of every spell of incapacity for work."
8. Immediately after subsection (2) of section 34 of the principal Act there shall be added the following new subsection: Amendment of section 34 of the principal Act.
- "(3) Where a claim for benefit under this Act is to be accompanied by a medical certificate, no such certificate shall be accepted as valid if it is signed by a medical practitioner who is also a member of the House of Representatives or by his partner or associate, or by any other medical practitioner having a similar relationship with him."

Substitution of section 72 of the principal Act.

9. For section 72 of the principal Act there shall be substituted the following:

"72. The rate of the allowance shall be:

(a) in respect of the first eligible child — one hundred and ten cents per week; and

(b) in respect of the second eligible child — ninety cents per week; and

(c) in respect of the third eligible child — fifty cents per week."

Amendment of section 80 of the principal Act.

10. In section 80 of the principal Act, immediately before the words "section 41" there shall be inserted the words "section 38".

Substitution of Second Schedule to the principal Act.

11. For the Second Schedule to the principal Act there shall be substituted the following:




