1. (1) Dan l-Att jista' jissejjah l-Att ta' l-1977 li jemenda l-Att dwar l-Għajnuna Nazzjonali (Emenda Nru. 2), u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1956 dwar l-Għajnuna Nazzjonali, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

(2) Dan l-Att għandu jibda jsehh fil-15 ta' Ottubru, 1977.

2. Minflok l-artikolu 3 ta' l-Att prinċipali għandu jidhrol dan li ġej:

- (c) għajnuna speċjali għal disimpieg."

10A. (1) Bla hsara għad-disposizzjonijiet l-oħra ta' dan l-Att, persuna li —

(a) qatt ma kienet impjegata jew xort'oħra tagħmel xogħol ta' qliegħ, sew f'Malta sew barra minn Malta, u

(b) tkun reġistrata bħala disokkupata taħt it-Taqsima I tar-Registru ta' l-Impiegi miżmum skond id-disposizzjonijiet ta' l-Att ta' l-1955 dwar is-Servizz ta' l-Impiegi, u xi regolamenti magħmula bis-saħħa tiegħu, u

(c) ma jkollhiex jedd li tirċievi —

(i) ghajjnuna soċjali taħt dan l-Att minhabba li tkun disokkupata, jew

(ii) pensjoni taħt l-Att ta' l-1948 dwar il-Pensjonijiet għax-xjuħ,

ikollha jedd li tirċievi ghajjnuna speċjali għal disimpieg bir-rata ta' 40 ċenteżmu fil-gimgha.

ACT No. XXXI of 1977

AN ACT further to amend the National Assistance Act, 1956.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title and commencement.

1. (1) This Act may be cited as the National Assistance (Amendment) (No. 2) Act, 1977, and shall be read and construed as one with the National Assistance Act, 1956, hereinafter referred to as "the principal Act".

(2) This Act shall come into force on the 15th day of October, 1977.

Substitution of section 3 of the principal Act.

2. For section 3 of the principal Act, there shall be substituted the following:

"3. Assistance under this Act shall be of the following kinds:

- (a) social assistance;
- (b) medical assistance; and
- (c) unemployment special assistance.

Addition of new section 10A to the principal Act.

3. Immediately after section 10 of the principal Act, there shall be inserted the following new section:

"Right to unemployment special assistance.

10A. (1) Subject to the other provisions of this Act, a person who —

(a) has never been employed or otherwise gainfully occupied, whether in Malta or abroad, and

(b) is registered as unemployed under Part I of the Employment Register kept in accordance with the provisions of the Employment Service Act, 1955, and of any regulations made thereunder, and

(c) is not entitled to receive —

(i) social assistance under this Act by reason of his being unemployed, or

(ii) a pension under the Old Age Pensions Act, 1948,

shall be entitled to receive unemployment special assistance at the rate of 40 cents per week.

(2) The provisions of subsection (1) of this section shall not apply to a person who is or was a married woman.”.

4. In subsection (2) of section 13 of the principal Act for the word “Wednesday” wherever it occurs there shall be substituted in each case the word “Saturday”.

Amendment of section 13 of the principal Act.

5. For Paragraph One of the First Schedule to the principal Act there shall be substituted the following:




Column A shall apply where the household does not own house of residence or part thereof.
