ATT biex ikompli jemenda l-Att ta' l-1952 li jirregola l-Kondizzjonijiet ta' l-Impieg.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħha f'dan il-Parlament, u bl-awtorità ta' l-istess, ħareġ b'ligi dan li ġej:—

Titolu fil-qosor.

1. Dan l-Att jista' jissejjaħ l-Att ta' l-1977 li jemenda l-Att li jirregola l-Kondizzjonijiet ta' l-Impieg (Emenda Nru. 2), u għandu jinqara u jiftiehem haġa waħda ma' l-Att ta' l-1952 li jirregola l-Kondizzjonijiet ta' l-Impieg, hawnhekk iżjed 'il quddiem imsejjaħ "l-Att prinċipali".

Emenda ta' l-artikolu 7 ta' l-Att prinċipali.

2. Is-subartikolu (2) ta' l-artikolu 7 ta' l-Att prinċipali għandu jiġi emendat biż-żieda tal-proviso li ġej fit-tarf tiegħu:

"Izda dan is-subartikolu ma japplikax għal xi proposti li jkunu jikkonsistu f'emenda ta' ordni li jirregola l-kondizzjonijiet ta' l-impieg u li jkunu maħsuba sabiex xi waħda jew iktar mill-kondizzjonijiet ta' l-impieg regolati b'dak l-ordni jingiebu jaqblu ma' kondizzjonijiet ta' impieg simili li japplikaw, jew li huma maħsuba li japplikaw, għal impjegati oħra, jew li jibdli xi waħda jew iktar minn dawk il-kondizzjonijiet b'mod simili bħal tibdil maġmūl, jew maħsub li jkun maġmūl, dwar impjegati oħra."

Emenda ta' l-artikolu 15A ta' l-Att prinċipali.

3. Fis-subartikolu (1) ta' l-artikolu 15A ta' l-Att prinċipali, minflok il-kliem minn "u dik iż-żieda tkun maġmūla" sal-kliem "fi-gholi tal-ħajja" u minflok il-kliem "b'ammont ekwivalenti" għandhom jidhru rispettivament il-kliem "u dik iż-żieda tkun dikjarata mill-Ministru b'avviż fil-Gazzetta li tkun ta' applikazzjoni ġenerali għall-impjegati *whole-time* kollha" u l-kliem "b'ammont ekwivalenti jew li jikkorrispondu għaż-żieda mogħtija mill-Gvern lill-impjegati tiegħu".

4. Fis-subartikolu (1) ta' l-artikolu 30 ta' l-Att principali, min-nufih wara l-kliem "jew b'ordnj li jirregola l-pagi" ghandhom jidhlu l-kliem "jew bi ftehim industrjali".

ACT No. XXXIII of 1977

AN ACT further to amend the Conditions of Employment (Regulation) Act, 1952.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Conditions of Employment (Regulation) (Amendment) (No. 2) Act, 1977, and shall be read and construed as one with the Conditions of Employment (Regulation) Act, 1952, hereinafter referred to as "the principal Act".

Amendment
of section 7
of the
principal Act.

2. Subsection (2) of section 7 of the principal Act shall be amended by the addition of the following proviso at the end thereof:

"Provided that this subsection shall not apply to any proposal which consists in an amendment of a wage regulation order and which is intended to bring any one or more of the conditions of employment regulated by that order into line with similar conditions of employment applicable, or intended to apply, to other employees, or to change any one or more of those conditions in a manner similar to a change made, or intended to be made, with respect to other employees."

Amendment of
section 15A
of the
principal Act.

3. In subsection (1) of section 15A of the principal Act, for the words from "and such increase consists" to the words "in the cost of living" and for the words "by an equivalent amount" there shall be substituted respectively the words "and such increase is declared by the Minister by notice in the Gazette to be of general application to all whole-time employees" and the words "by an amount equivalent or corresponding to the increase granted by the Government to its employees".


4. In subsection (1) of section 30 of the principal Act, immediately after the words "or wage regulation order" there shall be inserted the words "or industrial agreement".
