**ACT No. XL of 2024**

*AN ACT to appropriate a sum not exceeding six billion, four hundred and seventy-seven million, six hundred and ninety thousand, one hundred and thirty-one euro for the service of the financial year 2025.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

- Short title.           **1.**   This Act may be cited as the Appropriation (2025) Act, 2024.
- Appropriation.       **2.**   A sum not exceeding six billion, four hundred and seventy-seven million, six hundred and ninety thousand, one hundred and thirty-one euro shall be and the same is hereby charged upon the Consolidated Fund to meet expenditure during the financial year 2025 under the Votes specified in the Schedule to this Act.
