An ACT to amend the Prevention of Disease Ordinance, Cap. 36.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

Short title.

1. The short title of this Act is the Prevention of Disease Ordinance (Amendment) Act, 2025 and this Act shall be read and construed as one with the Prevention of Disease Ordinance, hereinafter referred to as the "principal law".

Deletion of
article 13 of the

2. Article 13 of the principal law shall be deleted.

Objects and Reasons

The objects and reasons of this Bill are to streamline legislation on restriction of movement of a person suspected of having a disease.
