**ACT No. VII of 2012**

*AN ACT to amend the European Union Act, Cap. 460.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

**1.** The short title of this Act is the European Union (Amendment) Act, 2012 and this Act shall be read and construed as one with the European Union Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 460.

**2.** Sub-article (2) of article 2 of the principal Act shall be amended as follows:

Amendment of article 2 of the principal Act.

(a) the words "If the Prime Minister by order declares that a treaty specified in the order being a treaty entered into by Malta after the 16th April, 2003 is to be regarded as one with the Treaty as herein defined, the order shall be conclusive that it is to be so regarded:"

there shall be substituted the words:

"If the Prime Minister by order declares that a treaty specified in the order being a treaty entered into by Malta after the 16th April, 2003, or that a Decision of the European Council specified in the order, being a decision that amends the Treaty, is to be regarded as one with the Treaty as herein defined, the order shall be conclusive that it is to be so regarded."; and

(b) in the second proviso the words:

"and the debate thereon in the Committee by the Chairman and the House shall upon the presentation of the Report of the Standing Committee proceed immediately to vote on the motion without debate."

shall be substituted by the words:

"and the debate thereon in the Committee by the Chairman. Following the presentation of such report the House shall proceed to debate and vote on such motion."
