**ACT No. XIX of 2011**

*AN ACT to amend the Malta Membership of the International Monetary Fund Act, Cap. 209.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title.

**1.** The short title of this Act is the Malta Membership of the International Monetary Fund (Amendment) Act, 2011 and this Act shall be read and construed as one with the Malta Membership of the International Monetary Fund Act, hereinafter referred to as "the principal Act".

Cap. 209.

Amendment of article 2 of the principal Act.

**2.** In article 2 of the principal Act, in the definition "Fund Agreement", for the words "but, for the purpose of sections 6 and 8, as from time to time amended" there shall be substituted the words "as from time to time ratified by Malta".
