IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, ħareġ b'liġi dan li ġej:-

1. It-titolu fil-qosor ta' dan l-Att hu l-Att tal-2014 li jemenda l-Att dwar ix-Xandir, u dan l-Att għandu jinqara u jiftiehem ħaġa waħda mal-Att dwar ix-Xandir, hawn iżjed 'il quddiem imsejjaħ "l-Att prinċipali". Titolu fil-qosor.

2. Fis-subartikolu (1) tal-artikolu 10 tal-Att prinċipali, il-kliem "jew f'xi liġi oħra" għandhom jiġihassru. Emenda tal-artikolu 10 tal-Att prinċipali.
3. Fis-subartikolu (1) tal-artikolu 16I tal-Att prinċipali, il-kliem "u f'kull liġi oħra" għandhom jiġihassru. Emenda tal-artikolu 16I tal-Att prinċipali.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

| Amendment of article 10 of the principal Act. | 2. In subarticle (1) of article 10 of the principal Act, the words "and in any other law" shall be deleted. |
| Amendment of article 16I of the principal Act. | 3. In subarticle (1) of article 16I of the principal Act, the words "and in any other law" shall be deleted. |
