ACT No. VI of 2016

AN ACT to amend the Sports Act, Cap. 455.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

1. (1) The short title of this Act is the Sports (Amendment) Act, 2016, and this Act shall be read and construed as one with the Sports Act, hereinafter referred to as "the principal Act".

Short title and commencement.
Cap. 455.

(2) This Act shall come into force on such date as the Minister may by notice in the Gazette establish, and different dates may be so established for different provisions of this Act.

2. In the Arrangement of Act of the principal Act, for the words "Establishment, functions and conduct of affairs of the Kunsill Malti għall-Isport" there shall be substituted the words "Establishment, functions and conduct of affairs of Sport Malta".

Amendment of the Arrangement of Act.

3. In article 2 of the principal Act, for the definition "Council" there shall be substituted the following:

" "Sport Malta" means the body established in accordance with article 4;"

4. The heading of Part II of the principal Act shall be substituted by the following:

Substitution of the heading of Part II of the principal Act.

5. Sub-article (1) of article 4 of the principal Act shall be substituted by the following:

"(1) There shall be a body to be known as Sport Malta."

6. In sub-article (4) of article 26 of the principal Act, for the words "Kunsill Malti għall-Isport (Loan) Fund" there shall be substituted the words "Sport Malta (Loan) Fund".

General
amendment.

7. (1) For the words "the Kunsill Malti għall-Isport" or "Kunsill Malti għall-Isport", "the Council" or "The Council", and cognate expressions, wherever they occur in the principal Act, there shall be substituted the words "Sport Malta".

(2) Any reference in any other law to the Kunsill Malti għall-Isport shall be read and construed as a reference to Sport Malta.
