**ACT No. XVII of 2014**

*AN ACT to amend the General Elections Act, to provide for the registration of voters who are persons that have attained the age of sixteen years.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

**1.** The short title of this Act is the General Elections (Amendment) Act, 2014, and this Act shall be read and construed as one with the General Elections Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 354.

**2.** In sub-article (2) of article 33 of the principal Act, for the words "as there are divisions." there shall be substituted the words "as there are divisions:" and immediately thereafter there shall be added the following new proviso:

Amendment of article 33 of the principal Act.

"Provided that the Electoral Register published in the format that is divided into as many parts as there are localities shall have an Annex indicating the registration of voters that have attained the age of sixteen years but have not attained the age of eighteen years on the election of 2015 onwards of the Local Councils or the Administrative Committees.".
