1. It-titolu fil-qosor ta' dan l-Att hu Att tal-2014 li jemenda l-Att dwar il-Karta tal-Identità u Dokumenti oħra tal-Identità u għandu jinqara u jiftiehem haġa waħda mal-Att dwar il-Karta tal-Identità u Dokumenti oħra tal-Identità, hawnhekk iżjed 'il quddiem f'dan l-Att imsejjah "l-Att prinċipali".

2. L-artikolu 4 tal-Att prinċipali għandu jiġi sostitwit b'dan li ġej:

Sostituzzjoni tal-artikolu 4 tal-Att prinċipali.

"Pussess ta' karti tal-identità.

4. Kull persuna ta' nazzjonalità Maltija li għandha 'l fuq minn erbgħatax-il sena għandu jkollha fil-pussess tagħha karta tal-identità valida, u għal dawn il-finijiet, għandha tapplika għaliha skont id-disposizzjonijiet ta' dan l-Att, mhux aktar tard minn xahar wara l-għeluq tagħha ta' erbgħatax-il sena. Fil-każ ta' persuni li huma ta' nazzjonalità Maltija u għadhom kemm irritornaw lura Malta bl-intenzjoni li jgħixu f'Malta b'mod permanenti, dawn għandhom jagħmlu talba għal hruġ ta' karta tal-identità ġdida mhux iżjed tard minn xahar wara li jirritornaw lura Malta."

3. Is-subartikolu (2) tal-artikolu 5 tal-Att prinċipali għandu jiġi emendat kif ġej:

(a) minflok il-kliem "id-data li fiha tindika l-bidu tal-validità tagħha u meta tiskadi, u n-numru tal-att ta' twelid tagħha kif mgħoti mir-Registru Pubbliku", għandhom jidhlu l-kliem "id-data li fiha tindika l-bidu tal-validità tagħha u meta tiskadi, u numru ta' identifikazzjoni tad-detentur li jista' jkun jew in-numru tal-att ta' twelid kif mgħoti mir-Registratur Pubbliku jew kull numru ieħor kif jista' jiġi mogħti lilha mill-uffiċjal awtorizzat"; u

(b) fil-paragrafu (b) tiegħu, minnufih wara l-kliem "l-indirizz tal-post prinċipali ta' residenza" għandhom jidhru l-kliem "f'Malta".

ACT No. XV of 2014

AN ACT to amend the Identity Cards and Other Identity Documents Act, Cap. 258.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives in this present Parliament assembled, and by the authority of the same as follows: -

1. The short title of this Act is the Identity Cards and Other Identity Documents (Amendment) Act, 2014 and it shall be read and construed as one with the Identity Cards and Other Identity Documents Act hereinafter referred to as "the principal Act".

2. Article 4 of the principal Act shall be substituted by the following:

"Possession of
identity cards.

4. Every Maltese national over the age of fourteen years shall be in possession of a valid identity card and for this purpose he shall make application therefor in accordance with the provisions of this Act not later than one month after his fourteenth birthday. In the case of Maltese nationals returning to Malta with the intention of setting up permanent residence, these shall make an application for the issue of a new identity card not later than one month after their return to Malta."

3. Sub-article (2) of article 5 of the principal Act shall be amended as follows:

(a) for the words "the date on which its validity commences and expires, and his act of birth number as given by the Public Registry", there shall be substituted the words "the date on which its validity commences and expires, and an identifying number of the holder which may either be his act of birth number as given by the Public Registry or any other number as may be assigned to him by the authorised officer"; and

(b) in paragraph (b) thereof, immediately after the words "the address of the principal place of residence", there shall be added the words "in Malta".

4. Sub-article (2) of article 8 of the principal Act shall be deleted and sub-article (1) thereof shall be renumbered as the whole article 8.
