ACT No. XIV of 2014

AN ACT to amend the Airports and Civil Aviation (Security) Act, Cap. 405.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives in this present Parliament assembled, and by the authority of the same as follows:-

Short title.

Cap. 405.

Amendment of article 2 of the principal Act.

1. The short title of this Act is the Airports and Civil Aviation (Security) (Amendment) Act, 2014, and this Act shall be read and construed as one with the Airports and Civil Aviation (Security) Act, hereinafter referred to as "the principal Act".

2. Article 2 of the principal Act shall be amended as follows:

(a) for the words "Manager Airport Security", wherever they occur, there shall be substituted the words "Head Aviation Security"; and

(b) for the definition "Manager Airport Security", there shall be substituted the following new definition

" "Head Aviation Security" means the public officer designated by the Minister to be responsible for the overall management and control of aviation security at specified airports and includes a public officer of his department so designated by him for the purposes of this Act. The Head Aviation Security and his department are the designated appropriate authority for Civil Aviation Security in Malta for the purpose of Article 9 of Regulation (EC) Nr. 300/2008 and of the Annex to Commission Regulation (EU) Nr. 18/2010;"

- 3.** In paragraph (f) of sub-article (1) of article 3 of the principal Act, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security". Amendment of article 3 of the principal Act.
- 4.** Article 5 of the principal Act, shall be amended as follows: Amendment of article 5 of the principal Act.
- (a) in sub-article (3) thereof, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security"; and
- (b) in sub-article (8) thereof, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security".
- 5.** In paragraph (a) of sub-article (3) of article 10 of the principal Act, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security". Amendment of article 10 of the principal Act.
- 6.** In article 11 of the principal Act, for the words "Manager Airport Security", wherever they occur, there shall be substituted the words "Head Aviation Security". Amendment of article 11 of the principal Act.
- 7.** In article 12 of the principal Act, for the words "Manager Airport Security", wherever they occur, there shall be substituted the words "Head Aviation Security". Amendment of article 12 of the principal Act.
- 8.** Article 13 of the principal Act, shall be amended as follows: Amendment of article 13 of the principal Act.
- (a) in sub-article (1) thereof, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security"; and
- (b) in the proviso thereto, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security".
- 9.** In article 15 of the principal Act, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security". Amendment of article 15 of the principal Act.
- 10.** In article 16 of the principal Act, for the words "Manager Airport Security" there shall be substituted the words "Head Aviation Security". Amendment of article 16 of the principal Act.
- 11.** In article 21 of the principal Act, for the words "Manager Airport Security", wherever they occur, there shall be substituted the words "Head Aviation Security". Amendment of article 21 of the principal Act.
