Earlier this week the Nationals Representatives received an e-mail from Ewa Szymanska, Head of Unit at the European Commission's Secretariat General, which informed us of the Commission's intention to strengthen relations with National Parliaments, as outlined by President Juncker in his mission letters to all Commissioners.

To that end, I have just received a telephone call from Mr Thomas Fich, co-ordinator for Inter-Institutional Relations, asking me to highlight any topics that our Parliament is currently discussing, plans to discuss or simply wishes to discuss with the Commission, so as to structure any visits that Members of the Commission may plan to make in the future.

In this regard, may I kindly ask you to consider the above - and have it possibly forwarded it to interested parties (the FEAC comes to mind, so I am copying Mr John Vella) - and highlight areas of interest for our Parliament so that I may bring this to the attention of Mr Fich?

Kindly note that while this initial request for feedback aims to collect input from various Parliaments in the coming weeks, the exercise is an on-going one, and Parliaments are free to submit and highlight new topics whenever deemed necessary.
