Dear Mr. Karl Camilleri (CEO Enemalta),

Following on from our recent discussions regarding the off spec deliveries which we understand have caused you issues and on a without prejudice basis, in the spirit of our continued good relationship we agree to pay \$250,000 (two hundred and fifty thousand US dollars) by way of settlement of these issues.

To show our continued cooperation and commitment to Enemalta we hereby also agree to ensure that the sulphur is brought down to the contractual 0.7% as an average across the entire contract. We further agree to pay Enemalta by way of liquidated damages to the sum of \$400k at the end of the contract in settlement of claims which may arise if either:

(a) We fail to bring the average sulphur level over the contractual deliveries down to 0.7%

Or

(b) We deliver cargo above the 0.7% sulphur specification between September 21st 2011 and the end of the current contract

By your agreement we will regard the matter as closed and final.

I hope that the above allows us to finally conclude these recent issues and we hope that this shows our continued desire to maintain the strong relationship that we have developed.
