ABBOZZ TA' LIĠI msejjah

Att biex jemenda l-Att dwar l-Impiegi u r-Relazzjonijiet Industrijali, Kap. 452.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, harget b'liġi dan li ġej:-

1. It-titolu fil-qosor ta' dan l-Att hu l-Att tal-2017 li jemenda l-Att dwar l-Impiegi u r-Relazzjonijiet Industrijali u dan l-Att għandu jinftehem u jinqara haġa waħda mal-Att dwar l-Impiegi u r-Relazzjonijiet Industrijali, hawn iżjed 'il quddiem imsejjah "l-Att prinċipali". Titolu fil-qosor.

2. Fl-artikolu 39 tal-Att prinċipali, il-kliem "tal-artikoli 36, 37 u 38" għandhom jiġu sostitwiti bil-kliem "tal-artikolu 36". Jemenda l-artikolu 39 tal-Att prinċipali.

Għanjiet u Raġunijiet

L-għanjiet u r-raġunijiet ta' dan l-Abbozz huma sabiex iġibu d-dispożizzjonijiet tal-Att dwar l-Impiegi u r-Relazzjonijiet Industrijali konformi mad-Direttiva (UE) 2015/1794 tas-6 ta' Ottubru 2015 li temenda d-Direttivi 2008/94/KE, 2009/38/KE u 2002/14/KE tal-Parlament Ewropew u tal-Kunsill, u d-Direttivi tal-Kunsill 98/59/KE u 2001/23/KE, fir-rigward tal-baħħara. Id-data tat-traspożizzjoni tal-imsemmija direttiva hija l-10 ta' Ottubru 2017.

**A BILL
entitled**

*An Act to Amend the Employment and Industrial Relations Act,
Cap. 452.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

Short title.

1. The short title of this Act is the Employment and Industrial Relations (Amendment) Act, 2017, and this Act shall be read and construed as one with the Employment and Industrial Relations Act, hereinafter referred to as "the principal Act".

Amendment of article 39 of the principal Act.

2. In article 39 of the principal Act, the words "articles 36, 37 and 38" shall be substituted by the words "article 36".

Objects and Reasons

The Objects and reasons of this Bill are to bring the provisions of the Employment and Industrial Relations Act in line with Directive (EU) 2015/1794 of 6th October 2015 amending Directives 2008/94/EC, 2009/38/EC and 2002/14/EC of the European Parliament and of the Council, and Council Directives 98/59/EC and 2001/23/EC, as regards seafarers. Deadline for the transposition of the said directive is 10th October 2017.
